Early September, they initiated the first part of the project, created a questionnaire and tested the form with some senators of their network. Then, they launched the questionnaire to all Senate presidents, asking them to forward it to their members. It was also sent to European senators. The answers are coming and the data processing has begun. We have already collected about 30 contributions and we will start in Tallinn to publish the "mentors of the week" in our different medias.

The second part will be to create a database of mentors, so that members and senators can get the opportunity to collaborate with them from any part of the world.

the voluntary contribution, creates the invoices for the contributions (and for other matters), sends these to the recipients and follows up on them (i.e. chasing missing payments). He manages the accounts of ASE and execute or receive payments, he prepares reports for the board meetings and the AGM and he supports the board in other matters when needed.
